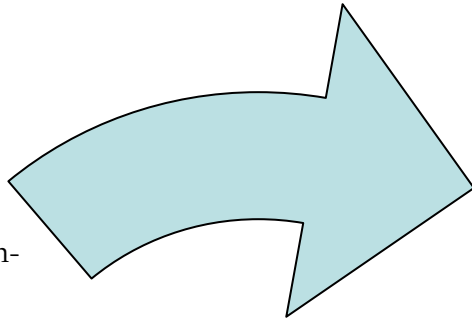

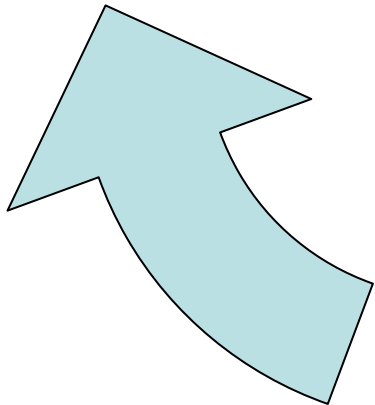

The Case for Outsourcing Accounting

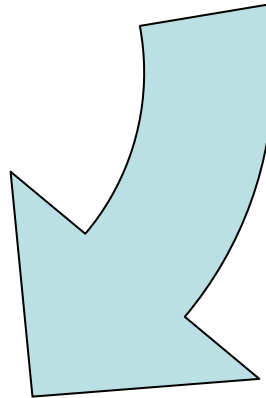
Daily You collect invoices, bank statements, and other accounting items in a folder for Kenny & Kenny's next visit.
